The undersigned is directed to invite a
reference to this Ministry's O.M. No. F.1(16)-E.III(C)/
68 dated the 5th November, 1966 on the subject
mentioned above and to state that the question of
allowing interest on the amount of retirement benefits
received in lump sum and deposited with the
Government of India by the officers deputed on foreign
service with U.N. Organisations has been under
consideration for some time on receipt of a number of
representations in this regard. The President is now
pleased to decide that interest may be paid, as for
deposits under G.P.F. Accounts, in respect of such
amounts including the amounts, which were deposited by
the Government servants who had served the U.N. Bodies
in the past and which are at present lying with the
Government even in respect of the past periods
commencing from the date the deposits have been made.

2. In so far as the persons serving in the
Indian Audit and Accounts Department are concerned,
these orders are issued after consultation with the
Comptroller and Auditor General of India.
