## OFFICE MEMORANDUM

Subject: Caretakers of Govt. buildings hired or owned by Govt. - grant of special pay & norms to determine the level of the post - proposal regarding.

The undersigned is directed to say that the Vth Central Pay Commission in Paras 55.37 and 55.38 have made certain recommendations regarding rationalisation of cadre of Caretakers and also norms for caretaking posts for Government buildings hired or owned by the Government. The President has now been pleased to decide as follows:-

- a) Group 'D' and Group 'C' staff borne on the regular establishment and deployed on caretaking duties, which is not to be treated as deputation to an ex-cadre post, may be paid a Caretaking Allowance of Rs.100/= and Rs.200/= per month respectively as compensation for long hours of work required by them. The number of persons entitled to the allowance should not, however, exceed the existing atrength of caretaking personnel in Groups 'C' and 'D' in all the applicable scales of pay taken together.
- b) No other additional remuneration in the form of Deputation (Duty) allowance or Special Pay shall be admissible to the personnel so deployed.
- of Caretakers, these posts shall be merged in the general ministerial cadres in the corresponding scales of pay. In other words, there will be no separate cadre of Caretakers anywhere in the Government.
- Where no persons from the cadre is willing to serve as Caretaker, the post may be allowed to be filled up on loan basis instead of deputation basis from other eadres. For filling up the post on loan basis the employees carrying the same scale of pay as applicable to the post or carrying scale next below with three years of service may be made eligible for appointment. On appointment on loan basis the employee may be allowed the scale of pay attached to the post (viz. post of Caretaker) in addition to Caretaking Allowance.

e) The norms and level of Care-taking posts to be as indicated below:-
